**Approve February 2006 Minutes**

It was noted that we had previously discussed having a judges score sheet to make sure judges are only counting the top 5 scores. It was decided that all host schools should have a mandatory judges meeting 15 minutes prior to the start of the contest. During this meeting the host school will remind oral judges to only write appropriate comments on the score sheet, remind written judges only the top 5 scores count, make sure all rooms are covered, and all questions have been distributed. A motion to approve the minutes was made by Lockport. Andrew seconded the motion. All were in favor and the minutes were approved.

**SWSC Conference Update**

Dave Daly commended us for our hard work throughout the last year. He said the Mathlete coaches had very good communication, were organized well and overall did a good job handling the first year of the new conference. He thanked everyone for their hard work especially Jim and Ricky. Dave also reported on the current status of the SWSC Conference and it's future plans. Dave reminded us he is the liaison for us with regards to the activity directors board and we can email him any time with questions.

## **Directory**

Ricky sent around a directory to be updated. Head coaches' cell phone numbers were added to improve communication between hosts. When Ricky emails the directory each school should check their information to make sure it is correct.

## **Communication between Hosts**

It was suggested that host schools try to keep their email up in case their cell phone is not working in the building. Jim also reminded everyone that it is very helpful to bring a coaches directory with you to the contests.

## **Updates from Question Writer & Statistician**

Ricky gave an update on the new organization of the question folders. In each compartment there are three folders. Each folder is for each round held in that room. If the contents are in a green folder, then calculators are allowed. If the contents are in a red folder, then calculators are not allowed. Answers will be in the back of the 1<sup>st</sup> folder. They will not be in each individual folder. There are 32 copies in each folder. The 5<sup>th</sup> compartment contains oral prep information, oral time signs and alternate room folders. In the alternate room folders there are 13 copies of each contest. After each contest please make sure your folder gets back to Ricky. Ricky will be gone Nov. 18-Dec 4.

## **Written Restrictions 2006-2007**

It was noticed that Competition E says it is closed to juniors and seniors. This should not be there because we now have a Fresh/Soph Calculator competition and a Junior/Senior Calculator competition.

## **Written Restrictions 2007-2008**

Jim stated the oral topic A Preview of Calculus is similar to the previous Statistics & Data Analysis oral. This oral has been changed and should now be more basic. Anyone in AP Stats should be able to do it very easily. The book we are using is listed on the restrictions sheet. Bradley motioned to approve the restrictions; Lockport seconded the motion and the minutes were approved.
