Meeting called to order at 4:30 p.m. by Mark Hampton from Bradley

Introduction and welcome of new coaches was short as almost everyone was a returning coach.

Prior Minutes: There was no need to amend the minutes from 9/3/13 because they were awesome, so Thornton moved to approve them as written and Thornridge seconded. They were approved unanimously.

Question Writer (Jim Aiu):

Jim confirmed that this was his last year for coaching due to some other commitments; however, he is writing questions through 2020. We are scheduled to use year B topics for 2014-2015 and those topics have already been approved by the coaches. He will be creating some proposed edits for year C and sending those around for coaches perusal next year.

Jim asked us to start considering how the Common Core might need to change Mathletes topics in coming years. There won't be any change to year B and we should be ok for year C, but after that, we may need to start a committee to check what topics we have scheduled and why. The discussion also brought up the problem that some schools switching to an Integrated Math curriculum will pose as well, the example of factoring, was brought up.

SWSC Business (Ian MacLeod):

Ian verified the rotation was correct as listed on the website, affirmed by webmaster. Verified that all schools have a representative present with the exception of HF which he knew about. Affirmed that no by-laws have changed. Affirmed that we have been solid on our cancellation policy. He asked if we knew of any calendar issues that he should bring to the Activity Directors? There were none. He asked us to submit names for pins and swsc certificates to our Activity Directors. If you have any questions about that, email Ian or your Activity Director. Ian congratulated us on keeping a good history and web presence. Ricky Perez submitted her final financial statement and receipts. Confirmed that Mathletes are doing a good job at keeping costs as minimal as possible.

Mark presented the proposed schedule for next year and asked for any feedback or discussion. There was none. Lincoln Way East moved to approve the schedule as presented, Andrew seconded, the schedule was approved unanimously and submitted to SWSC for final approval.
